All the eligible U.G. & P.G. students of Govt. Autonomous College, Rourkela are hereby informed to apply for **GOPABANDHU SIKHYA SAHAYATA YOJANA** through online application on or before **15.12.2022** available under Higher Education Department, Govt. of Odisha in the link - www.scholarship.gov.in and submit the two printed hard copies of the online application along with photo copies of all uploaded documents (Part-A & B Annexure) in **COUNTER No. - 5** of the College.

Eligible Students:

1. The student should belong to any of the following categories of families.
 - a) HIV/AIDS affected family (either Father or Mother or Both).
 - b) Households without shelter.
 - c) Destitute / living on alms.
 - d) Manual scavengers.
 - e) Particularly vulnerable Tribal Groups.
 - f) Legally released bonded labourers.
 - g) Single Mother Family (A mother who has a dependent child or dependent children and who is widowed, divorced or unmarried).
2. He/She should be a permanent resident of Odisha.
3. The student should have been enrolled for U.G. & P.G. courses on regular mode from the recognized Colleges/Institute/Universities in the state of Odisha.
4. The income of the household from all sources should be less than Rs. 10,000/- per month.


Documents Required:

1. Copy of Resident Certificate.
2. Copy of Income certificate.
3. Copy of Medical Certificate from the concerned Medical Officer regarding suffering from HIV/AIDS if required.
4. Copy of certificate relating to households without shelter from the competent Revenue Authority, if required.
5. Copy of Certificate towards being a single mother from District Social Welfare Officer, if required.
6. Certificate from being a Destitute / living on alms from the Local Sarpanch/Urban Local Body authority, if required.
7. Certificate of being a Manual Scavenger from the competent Authority, if required.
8. Certificate of being from a particularly vulnerable Tribal Groups from the District Welfare Officer, if required.
9. Certificate of being a Legally released bonded labourer from the District Welfare Officer / District Labour Officer / any competent Authority if required.
10. Copy of Bank Pass Book of the student. (Name of the Student, Bank Account Number & IFSC code must be mentioned on the copy of pass book.)
