Important notice for the applicants seeking admission into U.G. Courses under SAMS for Academic Session-2024-2025

Timeline for e-Admission in all (+3) Degree Colleges (Govt./Non-Govt. Aided College/ Unaided (Degree) Colleges/ Govt. and Non-Govt. Aided/Unaided Sanskrit (Shastri) Colleges/Universities imparting UG Courses) including Self Financing (Degree) Colleges of the State under Student Academic Management System (SAMS) is given below. Any changes in the timeline will be published in the newspapers as well as on the website www.samsodisha.gov.in. Kindly refer the Common Prospectus (CP) before filling up the CAF. The key points of U.G. e-admission for the academic session 2024-25 are as follows:

- 4 Year integrated B.A. B.Ed. / B.Sc. B.Ed. courses running at the following HEIs are included in the SAMS e- Admission process.
 - a. Gangadhar Meher University, Sambalpur
 - b. Utkal University, Bhubaneswar
 - c. Ravenshaw University, Cuttack
 - d. S.C.S (Auto) College, Puri
 - e. M.P.C. (Auto) College, Baripada, Mayurbhanj
 - f. Fakir Mohan (Auto) College, Balasore
- Admission to the B.Sc. ITM program at Ravenshaw University, Cuttack and the B.Sc. IST program at Gangadhar University, Sambalpur will be conducted through the SAMS U.G. (Degree) portal.
- Admission into the 3-year BBA and BCA programs at Government and Aided HEIs (excluding those running in PPP mode) has been included in the SAMS U.G. portal. Applicants can visit the eligibility criteria section of the Common Prospectus to view the requirements for enrollment in these programs.
- Admission into 5 years Integrated MBA (IMBA) and 5 years Integrated MCA (IMCA) at Utkal University will be conducted through the SAMS U.G. (Degree) portal.
- Admission into 5 years Integrated B.A (LLB) course at Madhusudan Law University, Cuttack will also be conducted through the SAMS U.G. (Degree) portal.
- Admission into 3 Years LL.B Course at Madhusudan Law University, Cuttack will be conducted after publication of Graduation (+3) results by all the Universities and Autonomous Colleges of the State for the Academic Session 2024-25 separately.
- The Phase-I will consist of 4 rounds of selection. The reservation and weightage will be continued for 1st and 2nd rounds of selection. In the 3rd round, the de-reservation of seats will be carried out in case of absence of the eligible applicants of a specific category. The 4th round will be the last round for Phase-I, which will be a Waiting List Round and the selection will be purely on merit basis.
- Applicants who got selected and taken admission during the Phase-I admission process (1st, 2nd, 3rd or Waiting List Round) in any Honor's subject at any Higher Education Institutions (HEIs) will not be eligible to participate in Phase-II and Phase-III admission processes. This implies, only the left-out applicants (who have passed instant/supplementary exam or the applicants who have not been admitted to any of the HEIs in Phase-I admission process due to any reason) will be allowed to participate in the Phase-II and Phase-III admission processes.

- During filling up the CAF, applicants are advised to enter **Name, Father's Name, Mother Name and Date of Birth as mentioned in 10th certificate.**
- From this Academic Session: 2024-25, both Temporary & Permanent type PwD applicants (40% & above) will get the reservation benefits in admission. **In addition to the current PwD reservation, the allotment of seats for PwD applicants for each subject should not be more than 10% of the intake capacity.**
- Applicants who got a seat in a round are advised to do the following options after publication round-wise selection:

Freeze: - If an applicant is satisfied with the allotted seat i.e. **both the HEI and Subject, S/he can choose this option.** After selecting the "Freeze" option, applicants have to pay the admission fees for that seat allocated. The required fees will be shown in the screen and s/he has to pay the fees in online mode only. **The applicants who will choose the "Freeze" option can download the Intimation Letter and have to visit the selected HEIs to complete the admission formalities.**

Slide: - If an applicant has accepted the allotted seat **but also wants for a better Subject as well as HEI in his/her higher preferences, s/he can choose this option.** After selecting the "Slide" option, applicants have to pay the admission fees for that seat allocated. The required fees will be shown in the screen and s/he has to pay the fees in online mode only. However, such applicants need not have to visit the allocated HEIs, as they will not get the Intimation Letter and they will wait for the subsequent round of selection.

Float: - If an applicant has accepted the allotted seat and also wishes a better Subject in their higher choice of subjects in the same HEI, s/he can choose this option. **After selecting the "Float" option, applicants have to pay the admission fees for that seat allocated.** The required fees will be shown in the screen and s/he has to pay the fees in online mode only. However, such applicants need not have to visit the allocated HEIs, as they will not get the Intimation Letter and they will wait for the subsequent round of selection.

- **Sports certificates obtained at the level of Schools (10th or below) will not be eligible to get any weightage marks for admission into U.G. Courses.** Applicants, who have obtained the Sports Certificate at the level of Higher Secondary (+2)/Equivalent shall only be given a weightage mark for admission into U.G. Courses.
- Any discrepancy that occurs during the admission period at the Institution level, the verifying Officers, Admission in-Charge and the Data Entry Operator (DEO) will be held responsible. They have to submit an undertaking in the supplied format in this regard.
